## **Terms and Conditions**

This Page sets out the terms of participation in the 2025 Hay bale decorating competition.

- 1. The Promoter of this Competition is the Rural Aid LTD (the "Promoter") (ABN 29 605 873 597), 70 Station Rd, Indooroopilly QLD, Australia.
- 2. Entry to the Competition is open to all Australian residents. An entrant must be an individual and not a company or organisation. Entrants under 18 years of age must have the consent of their parent or guardian to enter. Employees of the Promoter and their immediate families or any person associated with the Competition, are not eligible to enter.
- 3. Each entry must be entered in accordance with these Terms and Conditions. By entering the Competition, each entrant agrees to be bound by these Terms and Conditions. The Promoter may in its discretion refuse to award any prize to any entrant who fails to comply with these Terms and Conditions. All relevant instructions on the Promoter's website form part of these Terms and Conditions.

- 6. To enter the Competition, entrants can decorate small squares, large squares and/or round bales of day/straw/silage which must be the main product used in the construction of the entry. A photograph of the creation must submitted in a high-resolution, landscape by either posting the image on Instagram or Facebook, with the hashtag #BalesForRuralAid or #RuralAidHayBaleChallenge and tag @ruralaid in the picture, or by form submission on the Rural Aid website: https://www.ruralaid.org.au/hay-baledecorating-competition/
- 7. Each entry must include a photo fitting the entry details.
- 8. By submitting the Photo to the Promoter, you grant the Promoter and its licensees and assignees a nonexclusive licence to exercise all rights in perpetuity throughout the world in the Photo and all other material provided by you to the Promoter at any time.
- 9. Without limiting the rights granted to the Promoter under point 8, you specifically agree that point 8 grants to the Promoter the non-exclusive right throughout the world to communicate the Photo in whole or in part to the public on any media platform and you grant to the Promoter all associated rights necessary to exercise the above rights.
- 10. The Promoter will acknowledge the entrant by name, where practical on all submitted images.
- 11. The entrant/s whose entry is judged by the Promoter's panel of judges will win a placement and feature within the Promoter's electronic newsletters and social media channels. The winner will receive a pre-paid visa card of \$250 in value. To note, only first place will be drawn for this hay bale decorating competition.

- **15.** You acknowledge that the Promoter is under no obligation to exercise any of the rights granted to it by these Terms and Conditions.
- **16.** You agree that the Promoter may use your entry and any personal details provided to the Promoter for any promotional, marketing and publicity purposes of the Promoter in any media without notice and without any fee paid to you.
- 17. Decisions of the Promoter and its panel of judges are final and will be binding on each person who enters the Competition and no correspondence will be entered into. The name of the winner will be announced by Thursday, 12<sup>th</sup> June 2025 via Rural Aid social media platforms (provided there are a significant number of entries) and be a feature in the electronic newsletters on Tuesday 1<sup>st</sup> July 2025.
- **18.** If there is any event that prevents or hinders the Promoter's conduct of the Competition or the Promoter's ability to deliver the prizes to the prize winners, the Promoter may, in its discretion, cancel the Competition and recommence it at another time under the same conditions or select another winner.
